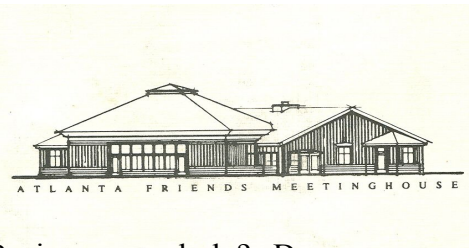

Our Quaker Ancestors in Georgia: The Wrightsboro Settlement

According to *GeorgiaTrend's* February 2012 issue, a group of Quakers facing persecution in North Carolina settled in McDuffie County, near Augusta, in 1768, establishing what is now known as the Wrightsboro settlement. Today, all that remains is a meetinghouse, a cemetery and the remnants of a nearby fort. The meetinghouse is in typical 18th century Quaker style. The cemetery's graves are unmarked; visible stones are those set up by denominations that succeeded the Quakers at the site, including Methodists, who still hold an annual gathering there. According to this source, the Wrightsboro Quakers were driven from the site by Native Americans and "outlaws of various stripes."

We find more information at the McDuffie County website. McDuffie County's roots go back to the 1768 settlement of Wrightsboro, Georgia's only Quaker settlement and the southernmost point of Quaker migration in North America. Wrightsboro survived as a village until the 1920s, but all that remains of the settlement is the Wrightsboro church (c. 1810) and the adjoining cemetery. The Wrightsboro Methodist Church of the Thomson Circuit, on the site of the defunct town of Wrightsboro, has been an active organization for over 125 years. Several veterans of the Revolutionary War and some who died at Gettysburg, Shiloh and Fredericksburg are buried in its historic churchyard. The founders of some of the oldest and most prominent families are also buried in the churchyard. Among them are the ancestors of Bishop Warren A. Candler, Judge John S. Candler and Asa G. Candler.

And here is more from William Wade Hinshaw, *The Encyclopedia of American Quaker Genealogy*, Vol. 1 (North Carolina): "Wrightsboro Monthly Meeting was located in Columbia (now McDuffie) County, Georgia. In 1770 the General Assembly of Georgia granted a tract of 40,000 acres in St. Paul's Parish to be held in trust for the Quakers. Here they began the town of Wrightsboro, on Town Creek, 16 miles from Appling, the county seat, and named it for Sir James Wright, Governor of the colony. The records date from 1773. In that year a preparative and a monthly meeting were organized in Wrightsboro by representatives sent from New Garden." Recorded certificates show that the Quaker population was made up of settlers from South Carolina, North Carolina, Virginia, Pennsylvania, and Burlington in West New Jersey. A list of the names of the members of the new meeting, compiled "by the order of Bush River Monthly Meeting ye 4th of ye 10th Month, 1774," and attested by William Wright and David Mote as clerks, is recorded in the minutes of Wrightsboro Monthly Meeting on the 3d day of 12th Month, 1774.

The existing minutes of the monthly meeting end in 1793. "From other sources, it is known that about 1800, just as in the case of the North and South Carolina meetings, there began a great migration to the Ohio Territory." Certificates were issued from Wrightsboro to Miami (Ohio) Monthly Meeting as late as 1805. The latest birth in the meeting, that of Mary Conner, was recorded in May 1805; this same family was issued a certificate by Bush River (S.C.) Meeting to Miami Meeting in November 1805, suggesting that the Wrightsboro Monthly Meeting had been laid down by that time.

Sally MacEwen: In Memoriam

Quakers have been identified and have identified themselves as the “peculiar people.” The origin of the phrase is attributed to Paul’s Letter to Titus 2:14. The adjective is found only in the King James version of the Bible and is rendered in later translations as “pure.” During the 17th century, “peculiar” signified the testimonies of equality, plain dress and speech, eg. simplicity. By the midst of the 19th century many of the “hedges” (constrictions) on Friends built up between those in the world and those of the world to keep Friends “pure” were lowered or missing entirely, such as marrying out of the meeting.



In remembrance of Sally MacEwen, let us look at the original word in the Greek Bible: *pēriōusios*. The word is used only once in the Bible -- in Titus. The Greek dictionary renders the English meaning as “costly, treasured = specially chosen.”

Atlanta Friends Meeting
Meeting for Worship with Attention to Business
April 22, 2012
Recorded Pending Approval

Meeting opened with a period of silent worship, after which Clerk David Foster read a selection from *Live the Questions: Write into the Answers*, by Barbara Parsons and Mary Morrison (Pendle Hill Pamphlet #354, 2001).

Query: On behalf of Ministry and Worship, Ron Nuse presented the query, “Do you express in your life the love for all people, the sincerity and simplicity, which Jesus lived and taught? Do you regularly make time for inward reflection and communion with God? Are you receptive to the Divine Light within, that its power growing in you may rule your life?”

Matters for Discernment

Ministry and Worship: On behalf of Ministry and Worship, Bill Holland reported that Ministry and Worship has received a report from the ad hoc group formed to discern the right relationship between Atlanta Friends Meeting and the Quaker Voluntary Service-Atlanta project scheduled to begin in the fall of 2012. Ministry and Worship recommends the following minute and structure:

Minute 12-04-01: On the recommendation of the Ministry and Worship Committee, Quaker Voluntary Service (QVS) - Atlanta will be taken under the spiritual care of Atlanta Friends Meeting. A local support committee for QVS-Atlanta will be formed under the direct care and oversight of the Ministry and Worship Committee, who will bring relevant updates and reports to Meeting for Business when appropriate.

The local support committee will take primary responsibility for the spiritual care of QVS-Atlanta volunteers, though it is understood that QVS and the Atlanta program are the primary responsibility of the QVS Board and Staff. The QVS Board and Staff will be responsible for the details of the QVS organization and its smooth functioning, though they may ask for input from AFM from time to time. This arrangement is brought to Meeting for Business for approval from now until the end of the initial QVS year ([July 2013](#)), at which time Ministry and Worship Committee will consider whether any important changes should be made for the second program year.

Atlanta Friend Meeting approves.

Maia and Stoph Hallward, Wesley Morris and Coryn Murphy, Aaron Ruscetta, Julia Ewen, and Jenny Foster have expressed their willingness to serve on the support committee.

Nominating: On behalf of the Nominating Committee, Steve Collins brought forth Rick Martinson as Clerk of Administration. Final approval will be sought in Fifth Month. Steve Collins brought forth for

final approval Karen Skellie as Meeting Archivist.

Minute 12-04-02: Atlanta Friends Meeting approves Karen Skellie as Meeting Archivist.

Clerk's Items: Citizens Climate Lobby letter endorsement. Upon reflection, the Clerk observed that while there was unity around the need for effective national legislation to reduce carbon consumption/emissions, Friends were not united around the specific mechanisms outlined in the letter. The Clerk expressed concern that the approved minute represented a compromise, borne of a lapse in adhering faithfully to Quaker process. The Clerk asked that the Meeting withdraw Minute 12-03-06 that endorses the Citizens Climate Lobby letter and have it be an opening agenda item for Fifth Month, after Friends have a chance to further season this concern, to allow clarity to come forth. Several Friends expressed their concerns with the process as well.

Minute 12-04-03: Atlanta Friends Meeting approves withdrawing Minute 12-03-06, and encourages Green Friends to bring to the Fifth Month Meeting for Worship with Attention to Business their recommendations for further discernment.

Reports

Ministry and Worship: On behalf of Ministry and Worship, Bill Holland reported that Ministry and Worship will hold a forum on April 29 after meeting on the Spiritual Basis of Meeting for Worship. Copies of Barry Morley's Pendle Hill pamphlet "Beyond Consensus: Salvaging Sense of the Meeting" are available from Ministry and Worship. We encourage Friends to attend as we explore together what we hope for in the Meeting for Worship with Attention to Business.

Ministry and Worship devotes a portion of its budget each year to provide scholarships for Friends interested in attending Friends General Conference Gathering or the Yearly Meeting sessions of Southern Appalachian Yearly Meeting. Registration deadlines for both events are quickly approaching. We particularly encourage attendance by first time attenders, and families. Friends should also know that Southern Appalachian Yearly Meeting and Friends General Conference could match scholarships for Yearly Meetings. Caroline Noyes, Mia Hallward, and Lynn Leuszler are receiving applications.

A forum has been scheduled for July 29 on the work of Howard Thurman. More information will be forthcoming.

Finance Committee: David Foster reported that the Quarterly treasurer's report would be presented in Fifth Month

American Friends Service Committee: Susan Cozzens reported that the ASFC Board recommended consolidating the nine regions into four regions. As a result of consolidation of the Middle Atlantic and Southeastern regions, ASFC-Southeast Region will now be part of the South region, extending from Delaware to Texas. Atlanta remains the headquarters of this region and Bonnie Horton, the newly hired Regional Director, will be based in Atlanta, while an Associate Regional Director will be located in Baltimore. No programs are being eliminated. Because the two executive committees will be consolidated and six Yearly Meetings will be covered under the new structure, all Yearly Meetings are encouraged to nominate (not appoint) members for the new consolidated executive committee.

Clerk's Items: David Foster gave a brief report on the recent SAYMA representatives meeting. Jonah McDonald has been hired as the Administrative Assistant for Southern Appalachian Young Friends (SAYF), starting in June 2012. The budget for the Yearly Meeting is about \$80K. Quaker Earth Witness (QEW) is offering \$500 grants for environmental improvements. *Faith and Practice* is

finished and will be posted on-line. Bulk orders will be printed and but it will also be available by print-on-demand. There is a committee charged with working on the Queries.

Approval of Minutes of Third Month Meeting for Worship with Attention to Business:

Minute 12-04-04: Atlanta Friends Meeting approves the Minutes of Third Month Meeting for Worship with Attention to Business with corrections.

The Greening of the Meetinghouse

Over the past few months, a number of not-readily-visible changes have been made to the meetinghouse, with the intention of reducing energy usage and thus shrinking our carbon footprint (and reducing our utility bills.) These changes were made to address deficiencies that were found during the energy audit of the meetinghouse in early 2011. The audit was provided at a very nominal cost by Georgia Interfaith Power and Light (GIPL). The changes were done with the help of a 50% matching grant, also provided by GIPL.

In December, 21 of our fluorescent light fixtures were upgraded from T12 bulbs with magnetic ballasts to T8 bulbs with electronic ballasts. This is expected to reduce electricity consumption in these fixtures by about 50%. These upgrades were made in classrooms A/B and C, the nursery, and the office – rooms where the lights are used 20 or more hours per week. Then, early in April, the insulation over the tiled ceilings (all classrooms, restrooms, kitchen, and office) was removed and upgraded, with spottily-placed fiberglass batts replaced by fiberglass blown in to a level of R-38 (supported by a fabric stapled to the underside of the roof trusses).

Next year we will evaluate the effect of these changes, comparing a year's worth of electricity and gas consumption after the changes with a year's worth just before. We project to shrink the meeting's carbon footprint by roughly eight metric tons of carbon dioxide per year, and reduce our utility bills by more than \$2,000 a year. An expectation of accepting the grant is that we will participate in GIPL's "pay it forward" program, contributing one-third of our actual savings on utility bills each year for the first three years. We'll keep you posted.
