Finance Committee: Paul Mangelsdorf, clerk of Finance, presented the Atlanta Friends Meeting 2019 Budget.

- Minute 12-16-2018-07: On the recommendation of the Finance Committee, Atlanta Friends Meeting approves the 2019 budget as proposed.
- Minute 12-16-2018-08: Friends thanked the committee and the clerk of finance for their clear explanation of how the budget is formed and used.

Administration Committee: Steve Collins, Clerk of Administration Committee, reported on behalf of Administration. At 11th Month Meeting for Business, the committee reviewed the results of the 2018 pilot of the Property Coordinator position and recommended that we approve it as a new position in the Meeting. The draft position description was shared. The summary section of that description states that the Property Coordinator "provides regular on-site management of building and grounds, coordination of hired contractors, and volunteer work. The Property Coordinator identifies problems and issues related to the building and grounds, coordinates ongoing contractor work, coordinates completion of general building maintenance tasks, coordinates permanent improvements and other large projects, responds to building- related emergencies, and completes administrative work related to the building and grounds." The job description will be formatted and added to the Atlanta Friends Committee Handbook.

• Minute 12-18-2018-09: On the recommendation of the Administration Committee, Atlanta Friends Meeting approves the creation of a new salaried, part-time position in the Meeting, that of Property Coordinator.

Reports

Ministry and Worship: Elizabeth Lamb, clerk, reported on behalf of Ministry and Worship reminding Atlanta Friends Meeting that we hold the ministries of a number of Friends in our care through anchoring committees. Each year we ask for a summary of these ministries. Today, we read the Summary of Ministry from Mary Ann Downey, which will be submitted to the Newsletter in the coming year.

Suchitoto Fund Committee: Bert Skellie reported on behalf of the Suchitoto Fund Committee, a summary of the report is below.

The Suchitoto Fund Committee was established in July 2016 as a result of a large bequest by Frank Cummings to the Meeting's existing Suchitoto Fund. The purpose of the fund is to support youth development in the Suchitoto, El Salvador, area. A further goal is to turn over the funds to an El Salvador-based entity before 2021.

During 2018, the Committee was pleased to receive an annual report from IDEAS (the US-based nonprofit coordinating in El Salvador for the Meeting). The youth-led Suchitoto non-profit, " The Association of Current and Graduated Scholarship Students from Suchitoto" (ABESUCHI), obtained legal status as an organization inEl Salvador. ABESUCHI made plans for work in three program areas: 1) strengthening the scholarship funds, 2) opening opportunities for training and other support for university graduates for employment or entrepreneurship, and 3) ABESUCHI's own organizational strengthening. ABESUCHI hired Evelin Gómez, a local accounting graduate, as a Bookkeeper. The responsibilities are to support ABESUCHI's financial management and the financial reporting required for the Suchitoto scholarship funds. ABESUCHI hired Teresa Deisy Cruz Artiga, a 25-year-old university graduate with a BA in Social Work from the rural Suchitoto community of Copapayo.

Quaker Voluntary Service: Liz Nicholson gave her annual report on the Quaker Voluntary Service in Atlanta, a summary of the report is below.

We are almost 4 months into the year with this seventh group of QVS Fellows. They have been working together in creating a home and community through weekly house worships, weeknight house meals, weekly business meetings, bi-weekly QVS days, and many informal conversations in deepening connections with each other. They have also been busy building relationships with folks at Atlanta Friends Meeting - you might have seen them tabling at the craft bazaar last week, walking around with their Spiritual Nurturers, greeting before worship, or teaching a first day school class among other things! Fellows have also been busy working at their respective site placement organizations.

Nationally, Christina Repoley has officially transitioned into new work with the Forum for Theological Exploration (FTE), and will continue to serve QVS in a consulting manner moving forward. Hilary Burgin, who was formally our Boston City Coordinator is stepping into the

Executive Director role, and we are so glad to have her seamlessly transitioned into continuing to carry out this vision of Quaker Service.

Care and Counsel: Bill Hooson, clerk of Care and Counsel, reported on behalf of the committee. Two appointed members of Care and Counsel have resigned. Rebecca Fiscal has dropped off for personal reasons, and Christina Lahowitch will be moving to Raleigh-Durham in the spring. Also Muireann Brennan has been asked to join Ministry and Worship. Care and Counsel is seeking additional members, invites interested friends to join in their work. Nominating Committee has been informed.

Ferguson Stewardship Cabin Committee: Mark Bryans, clerk, brought forward the annual report of the cabin committee, a summary is below.

This year the Ferguson Cabin had more than 70 different people use the cabins over 82 days. This is a decrease from last year. The cabins were not used in the first 5 months of 2018 except for the 2 work weekends. Most use occurred during the summer including the last 2 weeks of June, all of July and most weekends in August, September and October.

This year some major repairs took place: Partial dock and ramp replacement, removal of 2 dead trees, roof repair of the Dwight (old cabin), re-marking the boundary of the hill above the cabins. This coming year the cabin committee will finish the dock, place more rocks around the island, and complete the exterior of Irene (the new cabin). In the long-term the cabin committee is aware that the floor in Irene needs to be redone.

• Minute 12-16-2018-21: On the recommendation of Ferguson Stewardship Committee, Atlanta Friends Meeting thanks Emmet and Melanie Fuller for their service on the Committee and the many gifts they have offered.

Administration Committee: Jonah McDonald, office coordinator, bookkeeper and interim property coordinator, took the time to formally announce he is stepping down as office coordinator and property coordinator as of January 15, 2019. He will stay on as the AFM Bookkeeper. He thanked the community for the time he served and the ways the position allowed him to be released into the world to do other things in his life.

Steve Collins, clerk of Adminstration, continued to report on behalf of the committee. With Jonah McDonald's announcement that he has accepted a full-time position as an urban naturalist with DeKalb County, the Meeting needs to form search committee(s) as soon as possible for the Office Coordinator position and the new Property Coordinator position. Those interested in being on the committee(s) should contact Steve Collins or others on Administration.

Friend in Residence (FiR) Search Committee: At 11th Month Meeting for Business, the Meeting was asked to sit with the idea of possibly modifying the current FiR job description to eliminate or minimize the requirement for a formal "ministry" for the next FiR. Some history: Prior to adding the ministry function in 2007-2008, compensation for the FiR was the apartment, utilities, and a small stipend for health insurance. With the addition of the ministry component, the Meeting added a separate stipend based on a presumed 20 hours (approximate) per week ministry as part of the expanded job description. The current job description, which was updated in 2015, states that the ministry "may involve work within or outside of the Meeting", including "an established ministry of the Meeting", and that this an "area in which there is flexibility for each Resident to make it their own." The description further states that "the Resident may receive a stipend." Members of the Administration Committee who expressed their thoughts would like to see the ministry component continued, with the caveat that the meaning of "ministry" is clearly but broadly qualified in the job description. In addition to the AFM announcement sheet and newsletter, the position was advertised in the December issue of Friends Journal. The committee has received three inquiries about the position so far. Friends charge administration committee to move forward and discern how the ministry aspect fits into the person who is hired. The committee will report back at a later month.
