Friends Journal's June-July issue focused on vocal ministry, the sharing of messages from the Divine that are meant, not just for us, but for the meeting as a whole. In the introduction to the issue, Gabiel Ehri remembers being thanked for his "faithfulness" in giving a message, which he says "has always struck me as the perfect compliment and affirmation for Quakers' vocal ministry: not for the message itself, but for the discernment in allowing that of God within to filter through and outward to the gathered community." 

QVS Support - Steve Collins reported for the QVS Support Committee.

Minute 07-17-2022-01: Atlanta Friends Meeting approves the minute of appreciation for Rachel Carter, QVS Local Coordinator:

In the summer of 2020, National Quaker Voluntary Service (QVS) welcomed Rachael Carter, a former Atlanta QVS Fellow, as its next Atlanta QVS Local Coordinator. We extend our appreciation for Rachael's two years of service through the summer of 2022. Rachael's initial year as Coordinator came during a resurgence of anti-Blackness within the context of racial, gendered, homophobic, transphobic and economic unrest. In addition, there was the challenge of the global pandemic and QVS's decisive move to online (virtual) as a primary means of engagement.

Amidst all of this, Rachael was a steadfast, careful, prudent, curious (intellectually and relationally), loving, and socially and emotionally intelligent presence throughout their time

with us. We are deeply grateful for Rachael's service in our community during these past two years.

Rachael will soon be leaving for Pennsylvania to continue their leadership as QVS's Philadelphia Local Coordinator.

We wish Rachael well and hold them in the light in their next ventures and endeavors.

Ministry and Worship - Bill Hooson reported for the ministry and worship committee.

Minute 7-17-22:02- On the recommendation of the Ministry and Worship Committee, the Atlanta Friends Meeting approves and welcomes David Small into membership.

Administration: Steve Collins reported for the Administration Committee.

Anton Flores, Friend-in-Residence (FiR) for AFM since July 27, 2019, has agreed at the request of the committee to serve a 4th year. As prescribed in the Meeting's Handbook, Meeting for Business approval is required for such an extension.

Below is the relevant excerpt from the FiR job description. *Term*: Two year minimum, with an option to extend the term for up to two extra years with approval of the Meeting for Business. For any subsequent years thereafter, the Friend in Residence may apply for consideration for reappointment. Such reappointment could only be made after a search committee is formed, a search process for candidates is conducted, and any other applicants are genuinely considered.

Minute 07-17-2022-03: The Meeting approves the extension of Anton Flores for a 4th year of service as Friend in Residence through July 31, 2023.

At a later date, Administration plans to propose to the Meeting a modification to the above section of the FiR job description. Due in part to the impact of the Covid-19 pandemic on the Meeting during much of 2020 and 2021 and the inability of the Friend in Residence to fully perform the role for which he was hired, we feel that the Administration committee's option to extend the term of the FiR should be modified to allow more flexibility.

Reports

Working Group on Uses of Meeting House: Alison Mawle reported for the working group on the use of the meeting house.

The Working Group on Uses of the Meeting House has revised recommendations for precautions around COVID19. Other than the masking requirements, where we follow CDC recommendations, we want to move as close as possible to normal (pre- COVID) use. We will continue to monitor the local and national situation going forward.

Atlanta Friends Meeting Covid Guidelines - Update July 2022

Do not come if you don't feel well for any reason

1. Mask wearing will follow CDC guidelines for Dekalb county COVID assessment (updated on Thursdays):

https://www.cdc.gov/coronavirus/2019-ncov/your-health/covid-by-county.html

- a. Low masks optional
- b. Medium masks optional
- c. High masks required

Masks and hand sanitizer will continue to be available at the meeting house

- 2. Attendance sheets will no longer be needed, except for newcomers. If we are made aware that someone has come down with COVID, we will send a blast email if necessary
- 3. The kitchen will be reopened for regular use
- 4. Coffee set-up can be inside
- 5. Potluck will restart in September (9/3, Labor Day weekend), if we can get a group of volunteers to take this on as a regular commitment.
- 6. Water fountain can be switched back on. However, at the request of our renters, it will remain switched off for now.
- 7. Handshakes remain optional
- 8. First Day School will start as usual with masking optional now that vaccines are available for all children 6 months and older.

Ministry and Worship: Bill Hooson reporting for Ministry and Worship Committee

One of the great joys of being on the Ministry and Worship committee is working with new members, one of which is Sa'ed Atshan, who is transferring his membership from Central Philadelphia Monthly Meeting of Friends to Atlanta Friends Meeting. In April 2022 CPMM wrote a letter recommending him in glowing terms and approved his request to transfer. This 7th month we officially welcome Sa'ed Atshan into membership at Atlanta Friends Meeting.

Finance Committee - Paul Manglesdorf reported for the finance committee.

As of June 30, 2022, AFM is running a \$11,764 deficit YTD. A deficit through this part of the year is usual, as contribution income is largely received in the 4th quarter. The deficit is \$5,619 less than was budgeted through June. Further, donations arriving in late June are not included in this report due to the timing of processing those donations. So, the likely deficit is likely significantly lower. Income YTD is \$9,893 less than the same period in the prior year driven by the higher expenses this year and by the timing of donations noted above.

Expenses are running \$10,541 more than the prior year driven by occupancy expense and because we are making contributions to the Permanent Improvement Fund this year which was \$3,750 through June. Employee expense is higher than last year although below budget. Occupancy expense is over budget by \$1,006 and higher than the prior year by \$3,561. Higher Occupancy was a result of higher utility expenses (including the impact of a delay in the Solar Panels going live) and higher building maintenance (repairing an HVAC unit, repairing an electrical circuit in the kitchen, and repairing an outside faucet).

Compared to year-end, our balance sheet is \$41,808 smaller. This is the result of the YTD deficit of \$11,764 and payment of the initial amount due on the solar system installation and by minor changes in the balances of the other funds. On the asset side of the balance sheet Checking balances are \$23,288 lower and receivables (Undeposited funds and Due from Pay Pal) decreased by \$18,437. The negative Assistance Fund balance and the negative Gifts and Affiliations are timing issues, and both are now positive.

Year to date we are running a net deficit of \$11,754 which is normal for this time of year. In terms of expenses we are running over-budget. We had assumed we would be operating the solar panels by now but we are still paying our full electric bill. Gas bills were up this year so we are paying more than expected on this. We paid for the air handler for the library. We still haven't filled a few positions (Young Friends Program Coordinator and Property Coordinator) so we are under-budget on staff.

CUR-AFM - Lissa Place reported for CUR-AFM

CUR-AFM includes many Friends from different committees. Ad-hoc group composed a new official policy to help everyone in the meeting feel valued, safe, and respected. Intent is to help build and restore loving community. Initial draft of policy shared for questions and comments. Second draft included feedback. We have received significant feedback and incorporated those things into the document. We are now introducing it to meeting.

Interpersonal Racist Incident Policy

Introduction:

Atlanta Friends Meeting (AFM) is committed to being a multicultural anti-racist spiritual home for all, where we strive for everyone to feel valued, safe, and respected. Racism cuts us off from fully honoring that of God in all people and limits our spiritual community. To build an equitable Quaker community in a society shaped by racism, we need both ongoing anti-racist education and up-to-date policies that address harm caused by racism within our Meeting.

This racist incident policy is specifically related to interpersonal incidents among members and attenders of AFM in which one Black, Indigenous, or Person of Color participant experiences interpersonal racial harm due to another participant's words or actions. AFM policies or institutional practices that cause harm based on the race of one person or group will be addressed separately. The intent of this policy is to help AFM build and restore beloved community, to recognize the harm caused by racist incidents, to lovingly care for both the person who experienced the harm and the person who caused injury, and to lead to transformation and strengthened connection within our Meeting.

Both words and silences, actions and inactions may cause harm. Comments or actions, even those that are unintentional, may send negative messages which, cumulatively, contribute greatly to the daily racial stress and wounding for Black, Indigenous, and other People of Color (sometimes called "microaggressions"). The impact on People of Color can be very damaging even when the person who caused the harm did not intend to do so. We acknowledge that it is difficult to know the right things to do or say in this work and the best intentions can still have harmful impact. This policy is not intended to accuse anyone of wrongdoing but to help all of us to grow in our understanding of how to care for one another in our community. We trust that way will open as we do this work of anti-racism in our Meeting.

This policy sets out how interpersonal racist incidents, including microaggressions, among AFM participants will be addressed within our Meeting with attention to the Spirit and restoring beloved community. The process is intended to create a community of love and caring, keeping our community whole and addressing harms with an openness towards learning and coming together.

The purpose of this policy is to:

- 1. define an interpersonal racist incident occurring at AFM
- 2. address interpersonal racist incidents anywhere within the life of our Meeting
- 3. resolve, as far as is possible, any interpersonal racist incident that occurs
- 4. further the goal of AFM to become an anti-racist meeting connected spiritually to each other.

Racist Incident Procedure Outline

1. For the purposes of this procedure, an interpersonal racist incident is defined as one in which one Black, Indigenous, or Person of Color, AFM participant experiences interpersonal racial harm due to another AFM participant's words/silences or actions/inactions.

The person who experienced the harm defines the incident as racist.

This process presumes participation by the person who experienced the harm. However, the person who experienced the harm can choose not to participate in the full process. In such an event, the process will be modified accordingly.

- 2. The Standing Racist Incident Response Group is responsible for dealing with racist incidents. The Standing Response Group will be under the care of the Committee on Undoing Racism in Atlanta Friends Meeting (CURAFM). The Standing Response Group will stand ready for immediate response to any reported racist incidents that arise.
 - A. Composition of the Standing Racist Incident Response Group [referred to as the Standing Response Group]

The Standing Response Group will consist of 4 people.

- Standing Response Group membership will be confirmed through the Nominating process and Meeting for Business.
- CURAFM will work with Nominating in consultation with Friends of Color to identify potential Standing Response Group members.
- The Standing Response Group membership will include two members who will take turns serving as the facilitator in responding to incidents. Standing Response Group facilitators shall be trained in conflict resolution models, e.g. restorative justice practices.
- Standing Response Group membership is a two-year term. The initial Standing Response Group will have two members serve a one-year term to establish staggered rotation of membership.
- It is possible for the Standing Response Group to ask additional people to serve in response to a particular incident if that is appropriate and will not hold up the process of responding to the incident. CURAFM will keep a list of additional potential members who have agreed to serve in response to an incident if needed.
- The group responding to a particular racist incident will be selected from the Standing Racist Incident Response Group and any additional potential members in consultation with the person who experienced harm.
- B. Contact people include the CURAFM clerk and the two Standing Response Group facilitators. Names of designated contact people will be well-publicized through AFM sources such as announcements, newsletter, signage, and directory.
- C. Contact people will be responsible for regularly checking the designated voicemail and email accounts set up for the purpose of reporting racist incidents.
- 3. Reporting a racist incident.

Identities of all the people involved in racist incidents will be kept confidential.

A. Any of the following can report a racist incident:

- Person who experienced harm
- Witness (with agreement from the person who experienced harm)
- Someone who was confided in (with agreement from the person who experienced harm)
- B. How to report an incident:

Racist incidents are reported to designated contact people.

Contact people can be contacted:

- in person
- by phone
- by email
- 4. Upon notification of a racist incident, the Contact person will report the incident to the Standing Response Group.
- 5. The Standing Response Group begins the process of resolution. The Response Group will:
 - 1. invite the person who experienced harm to choose a person for accompaniment through the process, preferably someone from Atlanta Friends Meeting.
 - 2. meet with the person who has been harmed
 - 3. confer with the person who caused the harm in a spirit of love and caring. The person who experienced the harm may choose not to participate in this part of the process
 - 4. determine a process to repair the harm with the person who experienced harm
- 6. The Response Group, with the person who experienced the harm, discerns a path forward to repair the harm. The person who experienced the harm may choose to end the process at any time.

Repairing the harm may include:

- 1. being heard and held in worship by the Response Group
- 2. in a worshipful setting, the person who caused the harm listens to the experience of the person who was harmed
- 3. apology to the person who experienced the harm
- 4. education for the person who caused the harm
- 5. a description of how the community was harmed by the incident
- 6. examination of structural causes and appropriate changes to AFM policy & procedures
- 7. ongoing anti-racist education for the AFM community as a whole

The Response Group should be conscious that the process itself may cause painful reminders of other unresolved hurts for the person who was harmed.

- 7. We acknowledge that there may be instances where the person harmed chooses not to participate in the process or does not complete the process. We also acknowledge that there may be instances where reparation of the harm is not possible. That should not preclude Atlanta Friends Meeting from responding as a caring community, continuing anti-racist education, and examining structural racism within our meeting.
- 8. The Clerk of CURAFM will keep a generic record of all interpersonal racist incidents for the accountability and transparency of the organization. This generic record will include: when the incident was reported, type of incident, if/when/how it was addressed, and when and for how long the committee met. No names will be included in this generic record.
- 9. CURAFM will annually review the policy and any incidents that have been handled through this process to determine potential changes to the process, identify structural issues and appropriate supports within Atlanta Friends Meeting, and work to build a proactive anti-racist community.

Clarifying Questions

- Was there anything that precipitated this? How did it come about in the first place?
 - There was no precipitating event. Our meeting in a lot of different ways has been working on racism for decades. This is a part of a whole process our meeting has been working on.
 - There have been incidents over the past 20 years, but not necessarily right now.

- Is there any thought of using this as a policy template for other situations like LGBTQ or immigrant community.
 - It's something to consider.
- Could this policy be shared outside of this meeting as a template for other community organizations around or outside Atlanta? It is very clear.
 - Something we can consider once it is approved.

The work of the YFSC is outlined in the AFM Handbook. It is to establish guidelines for adults working with young friends, appoint clearness committees, model Quaker process and values, help with Young Friends Business Meeting, Coordinate with SAYF, coordinate YF events, and develop ways to include young friends in the life of the meeting.

SAYMA Representative report: Alison Mawle reported as the SAYMA Rep.

SAYMA YM51 report

The SAYMA yearly meeting was held at Warren Wilson College on June 16-19 2022, in a hybrid format. Attendees seemed very grateful to be finally back in person, and I was glad to be able to attend my first SAYMA meeting as the representative for AFM. Young Friends were also present in person, with SAYF and younger Friends having their own activities.

As many of you are aware, this was a particularly difficult year for SAYMA, with the real possibility that the organization might suspend operations, either partially or completely, for the coming year, or even that it might disband completely. I'm very happy to report that did not happen, and it was clear to me that a tremendous amount of work had been done leading up to this meeting to make sure that SAYMA had a path forward.

I don't mean to suggest that this was an easy meeting. It was not, and there was a significant amount of tension in all of the discussions. However, SAYMA does have a plan for the year ahead.

The following is a summary of the actions taken at Meeting for Business:

- 1. The Nominating Committee presented a full slate of positions for the coming year, which was approved. The Co-Clerks for 2022- 2024 will be Margaret Farmer (Ashville) and Daryl Bergquist (Birmingham).
- 2. A deficit budget was approved, which will use a significant amount of the surplus that has been under discussion. This removes the issue of how to handle the surplus.
- 3. URJ requested \$10,000 in funding, which was denied. However, the donor-directed fund will be released for use by URJ.

- 4. An anti-racist training program for SAYMA was presented and approved. The training is entitled "Understanding White Supremacy: What it is, how it works, and what Friends can do about it', and will have 3 facilitators; Sharon "Star" Smith, Shannon Roberts Smith and Angela Hopkins (Friends Center for Racial Justice, Ithaca). The goal is to offer the training to all of SAYMA over the next 2 years, starting with those who hold positions within SAYMA.
- 5. The Ministry and Nurture committee presented 2 reports; The State of SAYMA Monthly Meetings Report and The State of SAYMA Yearly Meeting Report, which were both accepted.

The official minutes have not yet been released, and when they are, I will share them and the relevant documents with AFM.

Committee Corner:

Search committees have been formed for the two open positions in the Meeting – Property Coordinator (PC) and Young Friends Program Coordinator (YFPC). The PC search committee consists of Jack Honderd, Carolyn Coburn-Allen, Beth Ruddiman, and Steve Collins. The YFPC search committee members are Carolyn Coburn-Allen, Laura MacNorlin, Jonah McDonald, Gwen Davies, Sage Hallward, and Steve Collins. Applicants for both positions have submitted letters of interest and resumes. Administration Committee - Solar Panels

Creative Solar has completed installation and related electrical work on the solar panel array. We await final inspection by Georgia Power before the panels become operative; unfortunately, Georgia Power has an extensive backlog of sites to inspect.

Social Concerns Committee: Glenn Plyler reported for the SSC

Information about our current activities: Our meeting on 10 July 2022 was focused on Women's Issues and Voting impact on those Issues plus support for Beacon Hill Alliance.

General opinion of SCC members in our meeting was that the loss of women's rights iis devastating to our society in ways that impact everyone's welfare. Danger is so great that it has deconstructed centuries of human rights advances.
