LETTER FROM THE CLERKS OF OUR YEARLY MEETING

Southern Appalachian Yearly Meeting and Association or SAYMA (http://www.sayma.org/) is our regional body of unprogrammed Quaker meetings. It includes Quaker meetings in Alabama, Mississippi, Tennessee, Kentucky, North and South Carolina, West Virginia and Georgia.

Dear SAYMA Friends,

We, Margaret Farmer (Asheville) and Daryl Bergquist (Birmingham), have been in the role of SAYMA co-clerks for three months now. This is a labor of love and we feel a sense of hope meeting with Friends in leadership roles and committees in SAYMA, listening together to discern way forward for the yearly meeting. SAYMA co-clerk is not a role that either of us would have envisioned filling a year ago. It is a calling for each of us, and feels more so as we continue the work. We meet together in a spirit of worship, beginning with centering worship, personal check-ins, the business at hand, and closing worship during which a new concern may arise.

Recognizing the multiple sources of stress we all have experienced (conflict within SAYMA, a deadly pandemic, national political upheaval, a world at war, and the devastating impacts of climate change), we undertake our work as co-clerks with hope that the tools and insights that we all develop and learn together may help us navigate wider world issues. Our basic tools as Friends include these practices: deep listening for Spirit and to others (especially those with whom we might disagree); recognizing "that of God" in every person; and seeking continuing revelation as way opens. We commit to including those most impacted by decisions in relevant corporate discernments. We support programs and processes that transform conflict, and we hold ourselves accountable for clear, transparent communication to SAYMA. We remain receptive to both eldering and "youngering."

SAYMA is moving forward. Committee clerks and committees are working diligently on essential issues supporting SAYMA's organizational functioning. The current SAYMA clerking team includes Susan Phelan (Administrative Assistant, Huntsville), Blake Burr (Recording Clerk, Memphis), Robert McGahey (Senior Assistant Clerk, Celo) and ourselves. The conflict transformation program is starting this month with ~70 Friends registered for the small affinity groups. Many monthly meetings have appointed members to Nominating Committee and to Ministry and Nurture Committee. We encourage other meetings to consider this.

RESOURCES ON LOBBYING FROM THE FCNL WORKSHOP SEPTEMBER 28

Missed the "Finding Hope with Congress" workshop? Our Atlanta Advocacy Team (a program of the Friends Committee on National Legislation or FCNL) is happy to share these resources with you so you can effectively call, write, and lobby on the issues you care about.

Start with this excellent piece: https://www.fcnl.org/resources/how-meet-congress

Then review the RAFT principles from FCNL (as in a life raft for effective advocacy):

Respond: The issues we work on and people we engage with don't operate in a vacuum. Put a context to help others understand why it's relevant by responding to something. For example:

- Respond to a current event (headlines or your community)
- Respond to a recent article in the news (especially if you're wring a letter to the editor)
- Respond to something you know your listener will care about
- Respond to major events happening in Congress

Ask: Your "ask" is the request you are making of your listener/reader. Your ask should be clear, specific and repeated. In lobby visits, say it at least 2 or 3 times so it is unmistakable.

Facts: Include facts about the issue to inform your listener and ground your point in trusted sources.

Tie in to your story/community: how does this connect to you or to someone you know? Demonstrate your connection to the district, to its people and to its institutuoions.

The F and the T go together and strengthen each other. It's hard to make an authentic personal connection if you only talk about facts. If you just tell personal stories and don't bring in any data about the outside world, it's hard to be taken seriously. When you put facts and story together, they are greater than sum of their parts. Each one allows the other to be heard more fully.

INVITATION TO A DEEPER COMMITMENT: EXPLORING MEMBERSHIP IN ATLANTA FRIENDS MEETING (RESOURCES FROM OCTOBER 30 FORUM)

I invite you to ask yourself: What brings me to Atlanta Friends Meeting and keeps me coming back?

On October 30, Ministry and Worship Committee provided a forum on the meaning and process of membership in Atlanta Friends Meeting. Two Friends who recently joined the meeting, Teri Key-Hooson and Alberta Guise shared their membership journey.

Quakerism is a spiritual path grounded in the integrity of direct experience. We have long recognized that we need committed companions to be faithful and practice. You become a member of the Society of Friends by joining a particular meeting. Membership in the Atlanta Friends Meeting is a mutual commitment. You are making a commitment to the Quaker path and to this community. In turn, the community is making a commitment to you. You can serve and to be served, you will be supported and have opportunites to support.

The Membership Process

Our full membership guidelines are available on the AFM Website at the bottom of the Members and Attenders Page: http://atlantaquakers.org/_site_pdf_docs/AFM_Membership_guidelines-201703.pdf

In brief, the process begins in individual discernment -- do you consider Atlanta Meeting your spiritual home? Members of Ministry and Worship are glad to talk with you about the membership process. The full membership guidelines provide some questions you might want to explore in your individual reflection.

- Once you have decided you wish to pursue membership, you write a letter addressed to the Clerk of the Ministry and Worship Committee, currently Bill Hooson (bhooson@aol.com). A template is below.
- Once Ministry and Worship receives the letter, the committee considers it at their next
 meeting and approves the formation of a clearness committee of several members who will
 meet with you. Clearness is a form of respectful worshipful inquiry. The meeting is intended
 to explore your request, asking, and answering questions.
- The clearness committee provides a recommendation to Ministry and Worship, who consider the report and bring a recommendation to business meeting.
- The Monthly Meeting for Business receives a report one month and waits a month before bringing the recommendation for decision. Often, the Application Letter is read to the meeting, and you are introduced as an applicant for membership.
- Once Monthly Meeting has approved (minuted) the recommendation, you are officially recorded as a member of the meeting. The spiritual journey continues!

Example of Letter Requesting Membership

The letter requesting membership can be a simple statement. It can also be a longer reflection on your spiritual journey and your sense of connection to Atlanta Friends Meeting. On the next page is a template adapted from a Quaker source to use as a starting point:

Peter Schantz was born on October 22, 1939, in Camden, New Jersey, to David Schantz and Ada Mullineaux Schantz and died July 26, 2022, of Alzheimer's disease. He channeled his childhood love of animals into a yearning to become a veterinarian. At the University of Pennsylvania, Peter's undergraduate degree in anthropology, in his words "Opened my mind to the world in all its cultural diversity." After his first year of vet school, he spent a summer working for the California Department of Health investigating an infectious disease of poverty and became interested in a career in public health. Ascribing to the "Peace Corps mentality" he was concerned about poverty and disease that inhibited development in large parts of the world. Convinced that veterinarians could have an impact, he completed a PhD in veterinary epidemiology and pathology at the University of California, Davis under the guidance of Calvin Schwabe, DVM, PhD who became a lifelong friend. After 4 years stationed in Argentina with the Pan American Health Association, he returned to the US in 1974 as an epidemiologist with the Centers for Disease Control. His service with the Commissioned Corps of the US Public Health Service spanned many countries, from Mexico and Ecuador to Nigeria, to China and Tibet, as well as the US. "I have had one foot in the veterinary arena and one foot in the human medical arena" he said of his career tracking, preventing, and treating zoonotic (animal-to-human) diseases.

Peter was a gifted athlete in high school and college, a key member of both the Quaker football and wrestling teams at Penn, receiving the Scholar/Athlete award his senior year. He was an athlete his entire life enjoying karate, running, skiing, bicycling, even rollerblading and snowboarding.

As a child Peter attended the Lutheran church with his family. Peter's mentor, Dr. Calvin Schwabe, became a close friend and was a member of Haverford Friends Meeting. On visits to see him, Peter learned about Friends from him. He began attending the Atlanta Friends Meeting with Mary Bartlett after their marriage in 1999 and his quiet grounded presence enriched our meeting.

Friends and family celebrated Peter's life and mourned his passing in a memorial meeting for worship on October 22, 2022, on what would have been his 83rd birthday. He is remembered for his lively curiosity about all life, always open to new experience, and for his quiet humility. His colleagues at CDC spoke of his dedication to being a tutor and mentor, always generous with his time and fully present. His appetite for life included an appreciation for food especially grazing on anything available including dog biscuits. His grandson recalled his grandfather making him 'special pancakes' on visits, special because he loved the time they enjoyed together. One of his daughter's shared a favorite passage from Albert Camus that guided Peter 's life.

"In the midst of hate, I found there was, within me, an invincible love. In the midst of tears, I found there was, within me, an invincible smile. In the midst of chaos, I found there was, within me, an invincible calm. I realized, through it all, that in the midst of winter, I found there was, within me, an invincible summer. And that makes me happy. For it says that no matter how hard the world pushes against me, within me, there's something stronger-something better, pushing right back."

In addition to his wife Mary Bartlett, Peter is survived by his children Aimee, Erica, and Brendan; brother David; sister Susan; stepsons Cody and Zach Smith; and grandchildren Tanner and Piper Wise, and Reid and Maddie Smith.

Although Peter has passed on, his quiet but strong spirit lives on in the many lives he touched.

Nominating Committee:

Lissa Place brought back the nomination presented tenth month of Gwen Davies to serve on the Young Friends Support Committee.

Minute 11-20-22:02: The Atlanta Friends Meeting, on the recommendation of the Nominating Committee, approves Gwen Davies for a two-year term on the Young Friends Support Committee from November of 2022- December 2024.

Reports

Finance Committee:

Paul Mangelsdorf presented the 2023 Proposed Budget for 2023. **[Editor's Note: These can be viewed at https://tinyurl.com/327ct2u2.]** During the pandemic, many expenses of meeting have been less than budgeted. Staff vacancies and reduced maintenance and childcare expenses kept costs less than anticipated. As we move out of pandemic, the committee projects many of our line items expenses will return to more normal levels. The meeting has filled vacant positions and is committed to providing a living wage for all those serving the meeting in paid roles. Before the pandemic, the annual transfer to the Permanent Improvement fund was \$20,000, the committee now recommends returning to more normal levels beginning with \$10,000 next year. (The use of the Permanent Improvement Fund to install solar, replace the roof, replace HVAC units has meant the meeting has not had to conduct any special capital campaigns since 2006.) Most Program expenses are projected to remain level based on committee requests, excepting a \$2000 increase to Social Concerns to meet pressing community needs and increased newsletter allocation for rising printing and paper costs. The Finance Committee did not receive a request from the Gathered Meeting Retreat Committee, so no funds were designated in 2023.

Increased expenses will mean meeting members and attenders will be asked to increase their contributions. The 2023 budget anticipates meeting members will give \$147,515, an over \$7,000 increase over 2022.

The paid positions of the meeting are Friend in Residence, Office Coordinator, Bookkeeper, Young Friends Coordinator, Childcare during meeting and the Property Coordinator (contract).

A Friend referred to the Gifts and Affiliation worksheet and expressed concern that the meeting has not raised its support for Wider Quaker Organizations over the last decade. We were encouraged to examine this as a meeting.

Friends were encouraged to share further questions and comments with the Finance Committee. The Proposed 2023 Budget will be brought back for discernment at Twelfth Month Meeting for Business.

Administration:

Steve Collins reported for the Administration Committee.

- The meetinghouse has a new front door that is attractive and locks and unlocks properly. It replaces the original front door.
- Solar Panel Updates. The final step in the solar panel project is the test and approval of the system by Georgia Power. This requires an on-site visit by a Georgia Power technician. The committee is hopeful this will be completed during November and we will begin to realize reductions in our power bills.

A friend raised a concern on the process for updating and revising the website. Updating the website will involve gathering requirements from the community and making a transition from one platform to another. The Web Manager anticipates a transition will require assistance of volunteers.

We asked the Administration Committee to propose a process to move this forward.

Minute 11-20-22:03: The Atlanta Friends Meeting asks that the Administration Committee propose a process for 1) gathering information from the community regarding desired requirements for a new website and 2) what will be required to implement the transition.

Social Concerns:

Glenn Plyer reported for the Social Concerns Committee.

- The Social Concerns Committee has sent copies of the Minute on Hospital Closures and Medicaid Expansion (Minute 10-16-22:01) to state legislators and encouraged their attention to the issues we raised.
- Glenn explained Social Concern's request for a \$2000 increase in budget for 2023. The committee's funds are largely used to respond to pressing community needs and support organizations. Inflation and increased costs mean that more members of the community will seek assistance to meet food and shelter needs. In addition, the committee has long-standing concerns for women's health and safety and BIPOC reparation restoration.
- Glenn made a personal commitment to make additional financial contribution to meeting and encouraged other members of meeting to join him as they are led.
- Glenn shared he has taken on a facilitator role in the yearly meeting's White Affinity Project. To fully be faithful to this responsibility, he will be resigning as Social Concerns Clerk. The committee has suggested a replacement to Nominating for their discernment.
- The Social Concerns Committee is working on the State of the Meeting submissions and will send it to the clerk by the deadline.
- Social Concerns will be hosting the December potluck and invites participation by other Friends.
- The Social Concern Committee thanked Mark Yates for his time and effort to encourage community participation in the 2022 election and runoff.

Ministry and Worship:

Elizabeth Lamb reported for the Ministry and Worship committee.

Austin Wattles Membership Application: The meeting has receive a letter requesting membership from Austin Wattles. Austin has had long experience among Friends. Austin was a member of Chattahoochee Friends Meeting, but his membership was laid down when Chattahoochee Meeting was laid down, so this is being considered as a new application rather than a transfer. A clearness committee has met with him, and all are clear. Ministry and Worship recommends his membership to the meeting and will return in twelfth month for final presentation.

To Atlanta Friends Meeting,

Lissa Place presented the nomination of Jennifer Crumpley to serve as clerk of Care and Counsel Committee.

Lissa reported that the pandemic had made the work of Nominating finding persons willing to serve more difficult.

Three members of Ministry and Worship have agreed to be reappointed for a second term of three years. They are Mary Ann Downey, Bill Holland, and Herb Edwards and their term would be from January 2023- December of 2025.

These nominations will be brought back for discernment in twelfth month.

Clerk's Items

The Acting Clerk reminded Friends that the Clerk has requested all committees submit their contribution to the State of the Meeting Report by December 18, 2022. This year we are asking committees to describe those areas that have given them joy and those areas that have been challenging.

The Acting Clerk reported that the Clerk has appointed the following Friends to serve on the Naming committee: Sally Ferguson, John Adams and Gwen Davies. These Friends have been charged to identify at least 2 Friends to serve on the Nominating Committee for a 3-year term. Friends interested in this service of discerning the gifts of members of our community are invited to contact members of the Naming Committee.

The Clerk has appointed four members to an Ad hoc committee to update the Kitchen. These members are Alison Mawle (clerk), Micheal Allison, Paul Manglesdorf and Anton Flores-Maisonet. Members are charged to develop a recommendation for updates to the kitchen to be presented to the Administration Committee by February 12, 2023. The recommendations will consider the different groups (Casa Alterna, long term and short-term renters and first day use) using the kitchen.

Announcements

Julia Ewen reported for the SAYMA Nominating Committee. There are many positions open and are needing to be filled. She reviewed some of the openings and requested the list of vacancies be linked. She encouraged Friends to offer their gifts in service to our wider association of meetings and worship groups with whom we are affiliated.
