INVITATION TO A DEEPER COMMITTMENT: EXPLORING MEMBERSHIP IN ATLANTA FRIENDS MEETING

Ask yourself: What brings me to Atlanta Friends Meeting and keeps me coming back?

On October 22, Clive Gordon, on behalf of Ministry and Worship Committee, provided a forum on the meaning and process of membership in Atlanta Friends Meeting. John Adams and Sally Ferguson shared their journey to membership and their reflection on what membership means to them today. Asa Kramer-Dicker shared why, even after growing up in Friends Meeting, attending Quaker College and participating in Quaker Voluntary Service, had not been led to become a member.

Quakerism is a spiritual path grounded in the integrity of direct experience. We have long recognized that we need committed companions to be faithful and practice. You become a member of the Society of Friends by joining a particular meeting. Membership in the Atlanta Friends Meeting is a mutual commitment. You are making a commitment to the Quaker path and to this community. In turn, the community is making a commitment to you. You can serve and to be served, you will be supported and have opportunities to support.

For more information contact Clive Gordon or any member of the Ministry and Worship Committee. Members are glad to answer your questions on membership, preparing for membership and other Quaker spiritual practices.

The Membership Process

Our full membership guidelines are available on the AFM Website at the bottom of the Members and Attenders Page: http://atlantaquakers.org/_site_pdf_docs/AFM_Membership_guidelines-201703.pdf In brief, the process begins in individual discernment -- do you consider Atlanta Meeting your spiritual home? Members of Ministry and Worship are glad to talk with you about the membership process. The full membership guidelines provide some questions you might want to explore in your individual reflection. Below is a summary of the steps involved:

- Once you have decided you wish to pursue membership, you write a letter addressed to the Clerk of the Ministry and Worship Committee. A template is attached.
- Once Ministry and Worship receives the letter, the committee considers it at their next
 meeting and approves the formation of a clearness committee of several members who will
 meet with you. Clearness is a form of respectful worshipful inquiry. The meeting is intended to
 explore your request, asking and answering questions.
- The clearness committee provides a recommendation to Ministry and Worship, who consider the report and bring a recommendation to business meeting.
- The Monthly Meeting for Business receives a report one month and waits a month before bringing the recommendation for decision. Often, the Application Letter is read to the meeting, and you are introduced as an applicant for membership.
- Once Monthly Meeting has approved (minuted) the recommendation, you are officially recorded as a member of the meeting. The spiritual journey continues!

Example of Letter Requesting Membership

The letter requesting membership can be a simple statement. It can also be a longer reflection on your spiritual journey and your sense of connection to Atlanta Friends Meeting. Here is a template adapted from a Quaker source to use as a starting point:

Minute-11-19-23:02: On the recommendation of Nominating Committee, Atlanta Friends Meeting approves Brent Wolff as Assistant Clerk of Meeting for a term starting January of 2024 until December 2025.

Ministry and Worship – Bill Hooson reported for M&W.

Atlanta Friends Meeting accepted Julie Hliboki's transfer of her membership to Santa Fe Monthly Meeting in July (Minute 07-16-2023-03), and now we are rescinding that minute. See letter from Julie below.

Minute-11-19-23:03: On the recommendation of Ministry and Worship Committee the meeting rescinds Minute 07-16-2023-03 requesting the transfer of Julie Hliboki to Santa Fe Monthly Meeting's care. Atlanta Friends Meeting will continue to care for her membership.

SAYMA Representative Meeting Request -

Jennifer Dickie reported on behalf of Alison Mawle (the SAYMA representative).

AFM has received a request from SAYMA to hold the April 6 Representative Meeting at AFM. The Hospitality Clerk and Zoom team are in support of the request. We were supposed to host them in 2020, but could not due to the pandemic, so this is like a reinvitation.

A Friend asked how the Hospitality Committee will organize hospitality for the Representative Meeting. The clerk responded that Alison Mawle (clerk of Hospitality) will reach out to people. It was noted that Friends should also reach out to Alison if they want to host people from out of town.

A Friend asked if the Representative Meeting has been hosted here before, and the clerk replied that it has.

Minute-11-19-23:04: Atlanta Friends Meeting invites SAYMA to hold their Spring 2024 representative meeting on April 6 in the Atlanta Friends Meetinghouse. AFM will provide a hybrid format, and we look forward to extending hospitality to SAYMA representatives.

Minute of thanks for Kathy Johnson's service as a Ferguson Cabin Steward – Bill Holland read the minute of thanks.

Some background: Forty years ago (in 1983) we received the deed for the Ferguson cabin from Dwight Ferguson in memory of Irene Ferguson. This was the result of a 6 month discernment process prior to this about how to do this transfer, and out of that came a plan for stewardship of the property.

As Kathy Johnson ends her long tenure on the Ferguson Cabin Committee, Atlanta Meeting extends our thanks for her service.

The Ferguson Cabin was offered to Atlanta Meeting by Dwight Ferguson in May 1983 as a loving tribute to Irene Ferguson.

In August of 1983 Kathy presented to business meeting a Proposed Stewardship Plan for Ferguson Cabin and Property. Kathy served as the general facilitator of the Ferguson Cabin Stewards Committee, one of the first six stewards. In this role, Kathy was instrumental in defining the practical and organizational work of the stewards committee.

In addition to her organizational role, Kathy has served as a living connection to the loving spirit of Dwight and Irene Ferguson. She is one of the first members of meeting to have visited the Ferguson

Cabin before it was offered to our meeting. She has maintained relations with the children of Dwight and Irene.

In the inevitable ebb and flow of committee life, Kathy has helped sustain the vision of the Ferguson Cabin place as a vital site of refreshment. Many individuals and groups continue to be nourished by this vital witness including: the men's retreat, Quaker Voluntary Service, the Friends School of Atlanta, Young Adult Friends, and SAYMA Ministry and Nurture.

Kathy has been eager to see the work continue and to hand over the care of the cabin to a new generation of stewards.

Atlanta meeting thanks Kathy Johnson for her years of service and loving stewardship of the Ferguson Cabin property. We treasure this place and her many services.

Minute-11-19-23:05: Atlanta Friends Meeting approves the minute of thanks for Kathy Johnson.

Ferguson Cabin Committee letter to neighbor —

Mike Aland read the letter to the neighbor of Ferguson Cabin.

Mike read a letter that has been drafted to send to a neighbor of the Ferguson Cabins. Please see the 8th Month Meeting for Business minutes for background.

If Friends wish to read the letter to the neighbor, they should contact Mike Aland.

A Friend asked if there is a need to have some type of waiver in case any damage is done to that patio (by us in using the right of way). Mike said this did not come up in conversation with the lawyer. Mike is not clear on this, but his belief is that we have the right to totally remove the patio on our property if we want. The clerk said it makes sense to ask the lawyer about this, and run any document we're asking the neighbor to sign by the lawyer. (The letter to the neighbor mentioned a document we would ask him to sign, but this document has not been written yet.)

A Friend asked if the document to be signed will be sent with the letter, or what the process will be. Mike said his intention was just that we send the letter, and the lawyer had suggested we include that part about signing a document. But it is not clear when the document signing would happen. The clerk suggested that we add to the letter that if the neighbor wants to continue using the property, he should sign the document included with the letter.

The clerk (as the person who is going to sign the letter) said she appreciates the legal clarity from working with the lawyer, and she also appreciates the reiteration of the intent to be good neighbors.

It was agreed that Mike Aland will ask the lawyer, Linda Dunlavy, with whom he has been working, to draft the signatory document to send with the letter.

Minute-11-19-23:06: On the recommendation of the Ferguson Cabin Stewards Committee, the clerk will send the letter written by the committee and reviewed by the the lawyer and the signatory document written by the lawyer to Matt Mitcham, a neighbor of the property, asserting our rights as property owners to limit his encroachment on the Ferguson Property.

Social Concerns Committee - Minute calling for an immediate ceasefire in the Israel/Palestine conflict (suggested cover letter) — Karen Morris reported for Social Concerns Committee [SCC].

It was discerned last week in Social Concerns Committee that a minute calling for a cease-fire between Israel & Palestine should be presented to AFM. They are asking that it be discerned today given the immediacy of the conflict.

Karen read the minute as initially proposed by SCC:

A minute concerning the conflict in Israel and Palestine

We urge our government to call for an immediate ceasefire, immediate and adequate humanitarian aid, and negotiations for long-term peace.

We urge our government not to add to the violence.

As Quakers, we believe each life is sacred.

A Friend asked that, since there is no international recognition of Palestine as a state, should we include the words Palestinian people instead of Palestine? Friends asked if there was discussion in the SCC meeting about using the words Palestine or Palestinian people. Karen said she doesn't think so. As background, she said, SCC borrowed language for this proposed minute from a much longer minute the Chapel Hill Friends Meeting created.

After several Friends shared their views on the matter, it was decided that the minute should say "Palestine" rather than "Palestinian people" so as to parallel the mention of Israel.

A Friend asked if this minute would be forwarded to someone in the government. Karen said this would be the intent. The clerk added that there is also a cover letter meant to be used in sending to government officials.

A Friend said that he thinks the minute feels underdeveloped in terms of the moral horror of what is going on. He feels this particular issue is very central to what it means to be a Quaker, that Israel and Palestine have a long-term conflict, and their response is to answer force with force, and as Quakers we need to hold up that what has been happening is unacceptable, not just calling for a ceasefire in response to the current conflict. A Quaker approach to this issue would be to break the cycle of responding to force with force. The entire approach is wrong and we need to uplift other ways to approach this.

The clerk said she knew SCC made a deliberate decision to remove some of this background about Quakers from the minute (which was originally in the Chapel Hill minute) and ask more directly for a ceasefire. Karen said that SCC was thinking that in order for a minute to be approved rapidly it would need to be short and forceful to the issues in the moment. Karen said she thinks we can consider a longer minute about the long-term issues later. The shortness of this minute is to have something for now to let our government know how we would like them to proceed.

The clerk read the cover letter:

[name of Quaker group] presents this Minute for your consideration and reflection of your constituent's values and concerns. [name of Quaker group] includes [number of members approving the minute] members in your state's district.

Members of the Religious Society of Friends, or Quakers, are part of an international Christian community who seek to facilitate the creation of a peaceful, equitable, just world, and an earth restored.

Minutes are a way that Quakers communicate actions we have chosen to take as a meeting, or worshipping body. They are vital to the Quaker community as a way to formally record a way forward and exercise faithful actions in the world.

We encourage you to act on the concern we raise in this Minute and look forward to hearing your response.

The clerk asked if Friends were ready to approve this minute as it stands, as well as ask SCC to work on a longer minute.

A Friend proposed adding the following to the beginning of the minute:

The Atlanta Friends Meeting are appalled by the events of Oct. 7 2023, but are equally appalled by the violent response by the government of Israel. We do not believe violence is a pathway to permanent peace.

Another Friend suggested that we change "each life" to "all lives" recognizing the complexity of the community of humanity rather than individuals.

A Friend suggested moving "As Quakers, all life is sacred" to the beginning of the minute.

A Friend suggested including that the Oct 7 events were perpetrated by Hamas, in order to separate the violence of Hamas from the Palestinian people.

The revised minute was read by the recording clerk:

A minute concerning the conflict in Israel and Palestine

As Quakers, we believe all lives are sacred.

The Atlanta Friends Meeting is appalled by the events of Oct. 7 2023 carried out by Hamas, and are equally appalled by the violent response by the government of Israel. We do not believe violence is a pathway to permanent peace.

We urge our government to call for an immediate ceasefire, immediate and adequate humanitarian aid, and negotiations for long-term peace.

We urge our government not to add to the violence.

A Friend said he must stand aside from this minute as read and from anything that does anything more than call for peace. He cannot condemn the Palestinian people for trying to break out of the oppression they are facing. A Friend suggested that these concerns could be addressed by leaving out the part about being appalled. The clerk addressed the Friend who would stand aside and asked if he would still stand aside with this change. He said he would stand aside from anything that condemns or criticizes Palestinians for what they are trying to achieve.

A Friend said her heart has resonated with all the concerns raised and wishes we could deliver all of them in the minute. But she is concerned that we keep the purpose of the document at front, which is to demand a ceasefire right now, and going forward from that we can continue to detail our other spiritual and practical concerns. Getting who we need to read this is most important, and we need to get them clearly the message that a ceasefire is needed right now.

A Friend said Hamas does not represent the Palestinian people. She said she would also stand aside if the minute criticized the Palestinian people, but Hamas does not represent them.

A Friend suggested that we remove the references to Hamas and the Israeli government, because all people are equal, so we should just say we are appalled. A Friend said he resonates with what is behind said, and wondered if the minute could simply say "we are appalled by the loss of innocent lives on both sides". The clerk asked if this means that we are not appalled by non-innocent lives being lost. It was decided that the minute should say "the loss of lives".

The minute, including these suggestions, was read by the recording clerk. The meeting was in unity on the minute and no one stood aside.

Minute-11-19-23:07: A minute concerning the conflict in Israel and Palestine.

As Quakers, we believe all lives are sacred.

The Atlanta Friends Meeting is appalled by the loss of the lives in this conflict. We do not believe violence is a pathway to permanent peace.

We urge our government to call for an immediate ceasefire, immediate and adequate humanitarian aid, and negotiations for long-term peace.

We urge our government not to add to the violence.

Reports

Ministry and Worship —

Bill Holland reported for M&W.

Shannon McNeal has written a letter requesting membership in the Atlanta Friends Meeting. Mary Ann Downey will clerk the Membership Clearness Committee. Suzie Lippold, Clive Gordon and Bill Holland will serve as members of the committee.

Beginning in 2021, Ministry and Worship developed a concern to expand our meeting's understanding and action on reparations and right relations. Our goal was to increase our knowledge and create the basis for tangible actions. The interest of other groups in meeting who shared this leading led to the formation of a meeting-wide ad hoc coordinating committee under the care of Ministry and Worship. In 2021, we approved our minute on Reconciliation and Right Relations (Minute 8-15-21:03). Over the past two years this work of education and discernment has continued to have life. We now believe it is time for the Atlanta Meeting to establish this Ad hoc committee as a full standing committee of the meeting with a defined purpose.

Proposed Minute: On the recommendation of the Ministry and Worship committee, the Atlanta Friends Meeting charges the Nominating committee in coordination with Ministry and Worship and Friends who served on the ad hoc committee for reparations and right relations, to develop a committee description for a new AFM reparations and right relations committee.

Nominating Committee -

Jim Tolmach reported for Nominating Committee.

Nominating Committee brings forward the name Derek Harootune Otis as Clerk of the Library Committee for a term of three years from January of 2024-December or 2026. We will bring Derek's name back for approval next month. If you haven't had a chance to get to know Derek, try to do so in the next month.

Nominating Committee brings forward the name Lisa Magee as Clerk of the Gathered Meeting Retreat Committee for a term of 2 years from January of 2024-December of 2025. We will bring her name back next month for approval. If you haven't had a chance to get to know Lisa, try to do so this month.

Nominating Committee brings forward the name Arianna Rodriguez as a teacher for First Day School for a term of one year effective immediately through June of 2024. If you haven't had a chance to get to know Arianna, please try to do so in the coming month. We will bring her name back for approval next month.

Nominating Committee brings forward the name Cathy Amanti as a teacher for First Day School for a term of one year effective immediately through June of 2024. If you haven't had a chance to get to know Cathy, please try to do so in the coming month. We will bring her name back for approval next month.

Nominating Committee brings forward the name Stacey Sharer as Treasurer of Meeting for a term of 2 years effective immediately until December of 2025. If you haven't had a chance to get to know Stacey, please do so in the next month. We will bring her name back for approval next month.

Naming Committee -

Bill Holland reported for Naming Committee.

The Naming Committee was appointed by the clerk with members announced at 9th and 10th month meeting for business. The members of the 2023 Naming Committee were Derek Harootune Otis, Lisa Magee, and Bill Holland. Bill Holland was asked to serve as clerk.

The clerk of meeting provided us with a charge which included copies of the committee descriptions for Naming and Nominating from the meeting handbook.

According to the committee description members of the Nominating Committee serve for three-year, non-consecutive terms. Reviewing the business meeting minutes there are currently six active approved members of the Nominating Committee. Three members end their terms in December 2023. The current committee is composed of five women, one man and one person of color.

We held five virtual meetings, assigned tasks and reported back. We made announcements in meeting and reached out to YAF Friends. We sought to engage the resources and discernment of the entire meeting. We want to raise to the meeting and future naming committees the importance of including YAF, non-binary and more BIPOC voices to the Nominating Committee.

We united on two recommendations:

- 1. Recommendation #1: We recommend extending Ellen McQueen from the current 2 yr. term to a regular 3 yr. term, extending her present appointment by one year.
- 2. Recommendation #2: We recommend Alison Mawle, Eric Glenn, and Sara Patenaude as the class of 2026 with a three-year term on the Nominating Committee beginning January 2024 and ending December 2026.

The proposed committee would consist of four women, two men and one person of color.

We will bring this recommendation back for discernment in 12th Month.

Submitted by Bill Holland on behalf of the 2023 Naming Committee. Bill said that it was wonderful to work with the Naming Committee this year, and they had very efficient and enjoyable meetings. He thanked the clerk for appointing them together.

Finance -

Paul Mangelsdorf reported for Finance Committee.

Paul presented the budget for the next year. See links here to the <u>preliminary budget</u>, the <u>gifts and affiliations</u>, and <u>notes on the budget</u>.

Things that are still up in the air about the budget: employee cost of living adjustment doesn't happen until the end of the year, when they will use the latest data to determine the adjustment.

Also, the Library Committee might produce a request for a slightly higher budget, since the new proposed clerk is excited about it.

We increased our contributions to Quaker organizations because of SAYMA, and SAYF might also ask us for more money because their budget from SAYMA is less this year. We also have one other Quaker organization a Friend asked us to include (the Bolivian Friends Education Fund). There is some support from SCC for that, and the Friend will look into this more. It was noted that Bolivia has more Quakers per capita than any country in the world (Evangelical Friends).

Social Concerns Committee is asking for a \$500 increase.

A Friend suggested there should be money in the budget for the gathered meeting retreat since we are nominating a clerk for it.

A Friend asked how Religious Education can order supplies. The clerk said she can help with that.

A Friend asked about the overspending on some categories, especially grounds. Paul said there was a large tree trimming that might get transferred to the permanent improvement fund.

Also the playground was mulched.

The bookkeeper is salaried, not contracted. Paul will correct this.

Ferguson Cabin Committee -

Mark Bryans reported for the Ferguson Cabin Committee.

Mark thanked Bill Holland and Mike Aland for the minute of appreciation and the letter to the neighbor respectively.

The cabins were well used again this year. There were 40 reservations over 110 days during the season (mid-April – mid-November) by individuals and groups including friends, family, an Atlanta Friends Meeting Men's Weekend and a Young Adult Friends Retreat. The Young Adult Friends Retreat was planned by Atlanta Friends Meeting young adult Friends, for 19 Friends from all around SAYMA.

Committee members joined two committee rotation opportunities including potluck set up and a slide show about the cabins at summer First Day school to acquaint the children with the cabins.

Reservation changes, online scheduling, and a new payment process were introduced this year. Payments are now calculated by the night/per cabin instead of by the person. Online, Friends are using a calendar to view available dates. Friends can email a scheduler to make reservations and use PayPal to send payments earmarked for the Ferguson Cabins but most Friends are still texting a scheduler and sending payments to the AFM treasurer. Friends on the committee are analyzing online scheduling and payment processes to make sure payments are complete and determine additional steps to make the online process more visible and workable.

Projects completed in addition to cleaning and general maintenance this year included new metal roofing over the sleeping portion of Treetops Cabin, two new window screens and crank hardware in the kitchen of Irene Cabin, a roof installed over the exterior upper entrance door to Irene, driveway repair, grading and gravel from Dwight Cabin to Treetops Cabin and the original ceramic counter top was installed next to the sink in Dwight Cabin.

The committee considered the possibility of opening the cabins for winter use due to requests from a few Friends. Having dealt with damage from frozen pipes in the past, the committee spent considerable time looking into the complexities of this request, including using the services of people local to Lake Burton for turning the water on and off. Committee members were unable to find a

workable solution for coordination of these services, so at this point in time, Friends are asked to limit winter use to Dwight Cabin only, to use the outhouse and to bring their own water. The committee will continue to consider ways to safely manage more off-season use in the future.

Cabins Committee members are working with attorney Linda Dunlavy following a request by Atlanta Friends Business Meeting to address an issue with a neighbor who is encroaching on the cabin's property by the lake. Cabin Committee members will present the draft of a letter to the November Atlanta Friends Business Meeting which will be sent to the neighbor from Atlanta Friends Meeting.

A Friend from the Finance committee expressed appreciation for everything the committee does, and they are doing a great job managing their own finances and the property and scheduling.

They typically have some money left over at the end of the year — in the past 5 years, they have run a surplus, but this year there were driveway repairs and legal fees.

The clerk asked where the money to pay for the legal fees is coming from. Mike Aland said it is a bookkeeper error that they have not followed up on. The Meeting is supposed to be the one paying for the legal fees. Paul will correct this.

Mike offered a small correction, that only the upper and lower parts of the driveway were repaired, not the middle part, so they saved on driveway repair costs.

The Religious Education and SAYMA representative reports will be carried over to next month.

Journey of Hope Speaker

The clerk reminded Friends that Bill Holland went to the World Day Against the Death Penalty and spoke on behalf of Friends. Frequently Asked Questions

What is the Journey of Hope organization?

The Journey of Hope...From Violence to Healing, Inc. (JOH) is an organization led by family members of murder victims, joined by family members of those who have been sentenced to death, and persons exonerated and released from death row. The purpose of the organization is abolition of the death penalty. Speakers from the Journey of Hope are available to address any group, either in person or online, to share their own stories of loss and healing, and to advocate for constructive responses to violent crime, instead of capital punishment.

When is the Journey of Hope in Georgia?

From time to time, the organization carries out speaking tours, both in the U.S. and in other countries. Early in 2024, a Journey of Hope speaking tour will take place in Georgia, in cooperation with Georgians for Alternative to the Death Penalty (GFADP). From January 26 through February 7, speakers will be available to address faith communities, classrooms, and community groups throughout the state.

The clerk asked if there were any Friends who wanted to shepherd this program for AFM. Mary Ann Downey and Bill Holland offered to help bring a speaker to AFM.


